

Promo Mechanics

1. The booking period is from May 15 to June 15, 2018 and the travel period is from May 15 to September 30, 2018.
2. The promotion is open to existing and newly approved principal and supplementary Metrobank Femme Signature Visa and Travel Platinum Visa cardholders who avail of the Water cottage and Beachfront cottage for a minimum of 2 nights stay with a minimum of two (2) persons in a room at El Nido Resorts – Lagen Island.
