

I. Qualification:

This promo is open to all Metrobank credit, debit and prepaid Mastercard cardholders who will purchase on the Lazada app within the promo period.

II. Promo Period and Discount:

5. Input the voucher code on the checkout page to apply the discount. Enter your shipping and billing information and select the credit card as payment method.
6. Enter your Mastercard Credit/Debit/Prepaid Card details and make sure to check if the discount was applied to total billing before proceeding to place the order.
7. Click “Place Order” to complete the transaction.

IV. Terms and Conditions

1. Discount can be used 3x per month throughout the valid promo period and dates.
2. Discount is applicable to all Mastercard Credit/Debit/Prepaid Cardholders. Discount is capped at P500.
3. Discount is applied automatically at the checkout only when the voucher code has been successfully applied on the order.

5. Discount amount cannot be applied retroactively.
6. Discount is not applicable to items marked “Voucher code not applicable on this item”.
