

PROMO MECHANICS:

I. Eligibility:

- 1. The Promo is open to all principal and supplementary cardholders of Metrobank credit, debit, and prepaid Mastercard issued in Philippines.
- 2. To join the Promo, cardholder must use a valid Metrobank Mastercard for a minimum P5,000 single-receipt purchase at any participating branch of The SM Store.
- Straight and installment transactions using a valid Metrobank Mastercard in-store and through Call-To-Deliver-Service are eligible for the promo, except transactions paid via iPay88/email billing.
- 4. Cardholders whose accounts are suspended or terminated are not eligible to join the promo.
