

Promo Mechanics

- 1. The Promotion is open to all Principal Metrobank Peso/Visa Mastercard, Platinum Mastercard, World Mastercard, Femme Visa, Femme Signature Visa, Travel Platinum Visa, Robinsons Mastercard, PSBank Credit Mastercard, ON Internet Mastercard and Toyota Mastercard cardholders in good standing. The Promotion is not applicable to YAZZ Prepaid Visa, Metrobank Dollar cards, Metrobank Prepaid and Debit cards.
- 2. The promo period is from November 8, 2017 to January 31, 2018. Redemption period is from November 15, 2017 to March 31, 2018.
- 3. For a single charge slip with a minimum retail or installment spend of the following tiers, the appropriate products may be redeemed in participating McDonald's restaurants:
 - a. For a single charge slip with a minimum valid retail or merchant installment spend of P3,000, redeem any ONE of the following:
 - i. FREE (1) Crispy Chicken Sandwich & (1) McFreeze or McFloat (22 oz.);
 - ii. FREE (1) McSpaghetti and (1) Regular Fries;
 - b. For a single charge slip with a minimum valid retail or merchant installment spend of P6,000, redeem any ONE of the following:
 - i. FREE (1) Cheeseburger Deluxe Small Value Meal;
 - ii. FREE (1) 1-pc. Chicken McDo with McSpaghetti Small Value Meal;
- 4. "Valid spending" includes all retail transactions such as, but not limited to, purchases at groceries, department stores, gasoline stations, restaurants, Internet and Mail Order/Telephone Order, foreign currency transactions, etc.; and merchant installment transactions such as but not limited to installment purchase of appliances, jewelry, etc.
- 5. Other transactions such as, but not limited to: Bills2Pay, Balance Transfer, Balance Conversion, Cash2Go, Cash Advance, are excluded from this promotion.
- 6. McDonald's treats code will be sent to the principal cardholder via SMS through the mobile number registered in Metrobank Card Corporation's (MCC) database starting November 15, 2017 for qualified purchases made from November 8, 2017 onwards. McDonald's treats code will be sent within three (3) business days from the time the qualified transactions were posted during the promo period. Qualified transactions made by supplementary cardholders will be credited to the principal cardholder's account.
- 7. To redeem the free McDonald's treats, the principal cardholder must proceed to any participating McDonald's branches nationwide, present the unique McDonald's treat promo code sent to the cardholder's registered valid mobile number in exchange for the corresponding actual McDonald's treat(s). One (1) McDonald's treats code is equivalent to one (1) free McDonald's treat. The McDonald's treats code may only be used once.
- 8. Cardholders shall not be allowed to redeem items in a Tier either higher or lower than what the cardholder is eligible to redeem in accordance to with the McDonalds treats code received from MCC.
- 9. Redemption is valid for dine-in or take-out orders only. Not valid for McDonald's Drive-Thru, Dessert Centres, McCafe or McDelivery.
- 10. A principal cardholder is allowed to redeem a maximum of three (3) McDonald's treats codes per McDonald's branch, per visit, per day. Redemptions are valid at all McDonald's branches except McDonald's Boracay, NAIA Terminal 3 and Kidzania stores. A principal cardholder is entitled up to a maximum of twenty (20) McDonald's treats codes for the duration of the promo period per unique Metrobank credit card.

- 11. A principal cardholder can redeem FREE McDonald's treats during regular operating hours of participating McDonald's branches nationwide.
- 12. All unredeemed McDonald's treats code(s) will be forfeited after the redemption period. In addition, the McDonald's treat code cannot be exchanged for cash, other products or discounts. The McDonald's treats code is not valid in conjunction with any ongoing promotions or discounts of McDonald's.
- 13. Splitting of transactions is prohibited and shall not be allowed for redemption. Splitting is defined as an intentional act of dividing a retail or merchant installment transaction into multiple charge slips to redeem more than one reward incentive. Split transactions is presumed when there are 2 or more transactions in one merchant outlet or establishment over one and the same product or service, and the interval of these transactions were made within 5-10 minutes.
- 14. MCC will no longer accommodate cardholder re-sending requests for McDonald's treats codes such as, but not limited to the following reasons:
 - McDonald's treat codes sent successfully to the principal cardholder but were accidentally deleted by the cardholder, members of their family or friends or due to upgrade or reformatting done to the cardholder's mobile device;
 - b. Due to loss, stolen or defective mobile device;
 - c. McDonald's treats code sent successfully to the principal cardholder's mobile number maintained in MCC's database during the promo and redemption period.

Should the principal cardholder request for a change in his mobile number during the promotion period, only succeeding McDonald's treat codes earned will be sent to the new mobile number of the principal cardholder. Previously sent McDonald's treat codes will be treated as part of the maximum redemptions cap of twenty (20) codes per unique Metrobank credit card.

- 15. Metrobank Card Corporation (MCC) reserves the right to disqualify a previously approved transaction that was cancelled or charged back within the program period. Should the cardholder receive the incentive but was later on deemed unqualified for not meeting the requirements of the incentives due to disputes arising from erroneous, invalid, fraudulent or unauthorized transactions, the cost of the incentive shall be charged by MCC to the cardholder's credit card account.
- 16. In case of dispute in respect to the cardholder's eligibility, actual charge slips presented, etc., MCC's decision shall prevail. All questions or disputes regarding the cardholder's eligibility for the promo or for any redemption shall be resolved by MCC at its discretion.
